COUNTY COUNCILLORS REPORT

- a) County Councillor Cherry Brooks reported that there are lots of meetings at County now that the shadow authority is established and operational. The biggest issue with trying to balance the budgets before the changeover is the rise in the cost of adult and childrens social care.
- b) A Highways programme of surface dressing is underway and will continue all over the County. Preventative measures, rather than reactive, are less intrusive to the community and cheaper.
